

### Get the facts before signing solar project lease

Recently, landowners across rural Iowa report having received solicitations in the mail offering land lease options for proposed solar projects.

Often, these letters offer attractive per-acre rental payments for various phases of a long-term proposed project, promising steady and predictable income. However, like all contracts, the devil is in the details.

Most of these letters are coming from companies outside of Iowa looking to lease land for future solar projects. Many of these letters erroneously refer to Iowa law; referencing a failed piece of state legislation (Senate File 2356) introduced last session. In fact, Iowa's electric cooperatives and many other groups registered in opposition to the legislation due to its likely negative impact on electric co-ops and our members.

Some solicitations also falsely claim local support for their solar initiative or that the electric output would somehow benefit the landowner's neighbors or the local electric cooperative. Letters also frequently include deceptive endorsements attributed to the Iowa Farm Bureau (IFB). This claim is untrue and IFB's legal team has worked to remove these perceived endorsements.

Before signing any agreement or contract, always consult your legal counsel. They can help explain the benefits and disadvantages of these agreements, answer any questions you have, and help negotiate fair and equitable terms. These are long-term agreements that can give the solar company exclusive options and control of your land for decades.

Spending some extra time up front to better understand the terms and conditions of the proposed agreement can save you significant time, money, and headaches in the future.

# Do not overlook overhead power lines

It can be easy to overlook things that we see every day, including overhead power lines. However, Nishnabotna Valley REC wants to remind you that failure to notice overhead lines can be deadly. If you or an object you are touching contacts or gets too close to a power line, you could be seriously injured or killed.

Overhead power lines require at least 10 feet of clearance in all directions. This distance rule applies to the power lines draped from pole to pole that line roads (distribution lines), as well as the drop-down lines that service homes or other structures.

If your job requires you to operate equipment in the vicinity of large transmission lines and towers, they require even more clearance than distribution and drop-down lines. That clearance is determined by the Occupational Safety and Health Administration (OSHA). OSHA mandates line clearance distances for all types of power lines.

Be mindful of overhead power lines when completing the following tasks:

### Home maintenance

Always be aware of the location of power lines, particularly when using long tools, such as ladders, pool skimmers, and pruning poles. Lower long tools and equipment before moving or transporting them.

Other safety tips include:



- Carry ladders and other long items horizontally whenever possible.
- Be careful when working on or around your roof.
- Never go on a roof in windy or bad weather.

### Yard work

When trimming trees, do not allow yourself or trimmers to come within 10 feet of overhead power lines, including service lines to your home or outbuilding.

Also:

- Do not trim trees near power lines; instead, leave this to certified line clearance tree trimmers.
- Do not use water or blower extensions to clean gutters near electric lines.

### Farming

Review power line locations and other potential electrical hazards with all workers at morning safety meetings.

After this summer's severe storms, many lines and poles could have experienced significant damage, causing line clearance to be altered.

Be especially cautious while using larger equipment such as sprayers, dump trucks, and augers.

### At work

Follow all OSHA distance requirements when operating dump trucks, cranes, concrete pump truck extensions, and when working on a roof or in a bucket.

### **Other reminders**

Do not come within 50 feet of a downed or damaged power line, and always consider a downed line to be energized. Warn others to stay away. Call 9-1-1 to report it.

Never climb trees near power lines. Even if the power lines are not touching the tree, they could come in contact when weight is added to the branch.

Look up and look out for overhead power lines. Contact can happen in an instant.

## **OFFICIAL NOTICE OF RATE INCREASE**

On August 29, 2024 Nishnabotna Valley REC's board of directors approved an increase in rates and charges affecting prices for electricity service that you receive.

This adjustment is necessitated by an increase in the cost of wholesale power. The increase will apply to your electricity consumption beginning November 1, 2024.

The increase in annual revenues will be approximately

\$98,605 or 0.55 percent.

Although the impact of the increase on your bill will vary depending on the type and extent of usage, average monthly increases per customer for the primary customer classes are found below. Charges to this account shall be supported so that a description of each type of charge will be readily available.

With winter on the horizon, we all know that colder weather is on the way. And here in Iowa that means two things are certain: falling temperatures and rising electricity usage.

From increased lighting load to brighten up those longer nights to added heating load as HVAC systems run longer and more often to fight against the frigid outdoor temps, the winter heating season can be costly for both members and the cooperative.

During the winter, members tend to use electricity more heavily early in the mornings and later in the evenings. These two "peak" times often contribute to the co-op's peak demand, the period of highest electrical use across our system.

Our wholesale power providers bill us, not only for the energy our members consume, but also for our system's peak monthly usage. These demand costs make up a significant portion of our wholesale power costs and are ultimately reflected in our rates.

By taking some simple steps, you can keep your electric bill lower, and reduce our wholesale demand costs to help keep everyone's rates more affordable.

### • Turn down the thermostat:

Even just a few degrees can make a difference!

In fact, for every degree you lower your thermostat in the winter, you can save between one and three percent on your heating bills.

### • Seal windows and doors:

Air leaks and drafts force your system to work harder than necessary.

Be sure to check and seal any leaks around exterior doors and windows with caulk and weatherstripping.

### • Level out the load:

When you can, try to stagger the use of major appliances like washers and dryers, dishwashers, and ovens. This helps lower not only your individual electric demand but also reduces the co-op's overall system demand.

Using small countertop appliances like an air fryer instead of an oven is a great way to help save energy and lower demand.

### Monthly maintenance

Be sure that your heating system is running efficiently by doing regular maintenance.

Even small things like checking and replacing a dirty furnace filter can make a big difference. A clogged air filter can cause your home's HVAC system to work harder, using up to 15 percent more energy.

### • Keep it cold:

When it's possible, use cold water to reduce the cost of water heating.

By setting your water heater to 120 degrees, you can help save energy and reduce mineral buildup in your pipes.

### Unplug unused electronics:

You can easily eliminate unnecessary energy use by unplugging devices when you're not using them.

Even when turned off, many modern electronics like televisions run in standby mode and can consume energy!

Plugging devices into a power strip makes it even easier to turn them all off at once with the push of a button or the click of a switch.

Donations are made from the fund to non-profit organizations and individuals in need. The program has been successfully implemented in more than 200 electric co-ops across the nation. The program is administered by Nishnabotna Valley REC's Board of Directors. Application forms are available at the REC office and are reviewed as needed.

## ATTENTION: RESIDENTIAL CUSTOMERS **NEED HELP WITH YOUR HEATING BILL?**

The 2024-2025 Low-Income Home Energy Assistance Program (LIHEAP) has been established to help qualifying low-income Iowa homeowners and renters pay for a portion of their primary heating costs for the winter heating season.

The assistance is based on household income, household size, type of fuel, and type of housing.

### WHEN TO APPLY:

- Elderly (60 & over) and/or disabled: October 1, 2024 to April 30, 2025
- All other households: November 1, 2024 to April 30, 2025

### WHAT TO TAKE:

- **Proof of Income** (for all household members age 18, and over) Depending upon your household income type, income documentation from the previous 30 days, the last 12 months, or the last calendar year, whichever is easier or more beneficial for you.
- Proof of Social Security Numbers for <u>all</u> household members (documentation required)
- Recent heat bill
- Recent electric bill
